The prerequisite courses may be taken at any regionally accredited college/university with a grade of C- or better. ### Frequently Asked Questions

#### 1. When do I turn in my admission application for Fall 2025?

The application will be available starting September 15, 2024. You should submit the application, transcripts of each college attended, essay and three professional recommendation forms before the priority deadline of April 1, 2025. To ensure documents are received before the priority deadline, it's recommended that you apply two months before the deadline.

#### 2. Can I apply for Spring admissions?

Yes, you can apply for Spring admissions. Refer to the Spring Admissions Prerequisite and FAQs sheet for details.

New students enter the Health Care Disparities, Diversity and Advocacy program in the Fall or Spring semester.

#### 3. Can I apply for Summer admissions?

No, we do not admit new students for summer.

#### 4. Can I enroll in classes part-time?

Yes, enrollment is offered full-time or part-time. View the courses and details [here](#).

#### 5. I've not finished with all the prerequisite courses. Can I still apply for admission?

Yes, if the majority of the prerequisite courses are completed, you may apply for admission. The more prerequisite courses you have completed at the time of application, the better.

Admitted students must have no more than 3 missing prerequisite courses by the first day of enrollment in the School of Health Professions.

For this purpose, please note that a science course with a corresponding lab, is considered one course and not two courses, e.g. Human Anatomy and Physiology lecture and lab.

#### 6. What factors are considered in the [admission process](#)?

Admission to the program is competitive and holistic. This means that an admissions committee will look at all the factors below when admitting a student. Meeting the minimum requirement does not guarantee acceptance.

- (1) A minimum of 2.50 in all three areas: Overall GPA, science GPA and prerequisite GPA
- (2) Number of completed prerequisite courses at the time of application
- (3) Essay (the essay prompt will appear on the online admission application)
- (4) Three Professional Recommendations

#### 7. When will I receive my admission decision?

An admission decision will be completed near June 2025.

### Frequently Asked Questions

**8. I was accepted for Fall 2025 to Health Care Disparities, Diversity and Advocacy. Due to incomplete prerequisite courses, I was accepted into the program conditionally. What is the deadline to complete my outstanding prerequisite courses?**

By the first day of enrollment in the School of Health Professions, you can have a maximum of 3 outstanding prerequisite courses.

For full-time students, these outstanding prerequisite courses must be completed no later than August 2026. Our recommendation is to finish the course(s) as soon as possible.

For part-time students, these outstanding prerequisite courses must be completed no later than August 2027. Our recommendation is to finish the course(s) as soon as possible.

**9. How can I learn more about the program?**

**10. Do you offer an on-line option?**

Yes, the program is offered in an online learning format. You will have online courses and preceptorships.

**11. When are courses offered?**

Courses are offered in the Fall and Spring semesters. You can view the curriculum [here](#).

However, if you were admitted with missing prerequisite courses, you may need to take coursework during the summer semester(s) to complete this requirement.

**12. What is a preceptorship?**

Students will complete 2 virtual preceptorships, in Advocacy and Disparities. Community and clinical experts from across the country guest lecture bi-weekly. This is supplemented with webinars and virtual conferences. Students are required to interact with clinical experts and participate in question and answer sessions. This is a synchronous virtual class.

**13. I already hold a Bachelors Degree. Can I apply for this program?**

Yes, you can apply. Upon graduation, you will earn a second Bachelor Degree.

**14. I already hold a bachelors degree. Can you waive all the prerequisite courses?**

No, despite holding a prior degree, prerequisite requirements cannot be waived. However, applicable courses from your prior degree may be used toward the prerequisite requirements.

**15. When I graduate, what degree will I earn?**

You will earn a Bachelor of Science in Health Care Disparities, Diversity and Advocacy. Your degree will be awarded from The University of Texas MD Anderson Cancer Center.
