Elective Courses Applicants may complete any college-level academic course of their choice to fulfill elective requirements. However, remedial, developmental, or workforce-level courses are not accepted. Applicants also have the option to take up to 9 semester credit hours of elective courses at the School of Health Professions. These courses will count toward the maximum of three courses that may be outstanding at the time of enrollment. Note: Admitted students may have no more than three (3) outstanding prerequisite courses on the first day of enrollment in the School of Health Professions.		30

Application for Fall 2026

Applicants to the Healthcare Analytics and Advocacy program may apply for admission when the majority of prerequisite courses are completed. The prerequisite courses may be taken at any regionally accredited college/ university with a grade of C- or better. Courses are listed using the Texas Common Course Numbering System (tccns.org).

Frequently Asked Questions

1. When do I turn in my admission application for Fall 2026?

The application will be available starting September 15, 2025. You should submit the application, transcripts of each college attended, essay and three professional recommendation forms before the priority deadline of April 1, 2026. To ensure documents are received before the priority deadline, it's recommended that you apply two months before the deadline.

2. Can I apply for Spring admissions?

Yes, you can apply for Spring admissions. Refer to the Spring Admissions Prerequisite and FAQS sheet for details.

New students enter the Healthcare Analytics and Advocacy program in the Fall or Spring semester.

3. Can I apply for Summer admissions?

No, we do not admit new students for summer.

4. Can I enroll in classes part-time?

Yes, enrollment is offered full-time or part-time. View the courses and details here.

5. I've not finished with all the prerequisite courses. Can I still apply for admission?

Yes, if the majority of the prerequisite courses are completed, you may apply for admission. The more prerequisite courses you have completed at the time of application, the better.

Admitted students must have no more than 3 missing prerequisite courses by the first day of enrollment in the School of Health Professions.

For this purpose, please note that a science course with a corresponding lab, is considered one course and not two courses, e.g. Human Anatomy and Physiology lecture and lab.

6. What factors are considered in the admission process?

Admission to the program is competitive and holistic. This means that an admissions committee will look at all the factors below when admitting a student. Meeting the minimum requirement does not guarantee acceptance.

- (1) A minimum of 2.50 in all three areas: Overall GPA, science GPA and prerequisite GPA
- (2) Number of completed prerequisite courses at the time of application
- (3) Essay (the essay prompt will appear on the online admission application)
- (4) Three Professional Recommendation forms

7. When will I receive my admission decision?

An admission decision will be completed near June 2026.

8. I was accepted for Fall 2026 to Healthcare Analytics and Advocacy. Due to incomplete prerequisite courses, I was accepted into the program <u>conditionally</u>. What is the deadline to complete my outstanding prerequisite courses?

If you are enrolled in the full-time track, you must finish any outstanding prerequisite course no later than August 2027.

If you are enrolled in the part-time track, you must finish any outstanding prerequisite course no later than August 2028.

Our recommendation is to finish any outstanding prerequisite course as soon as possible.

9. How can I learn more about the program?

You can view a pre-recorded information session, which is on the HAA homepage here.

10. Do you offer an online option?

Yes, the program is offered entirely in a virtual format. All courses are online, with some classes meeting synchronously, while others are asynchronous.

11. When are courses offered?

Courses are offered in the Fall and Spring semesters. You can view the curriculum here.

However, if you were admitted with missing prerequisite courses, you may need to take coursework during the summer semester(s) to complete this requirement.

12. What is virtual seminar?

Virtual seminars allow Healthcare Analytics and Advocacy professionals to meet with students in realtime via virtual classrooms, sharing their professional experiences in a wide national arena. Students have the opportunity to interact with each professional to demonstrate knowledge gained and learn professional skills under the guidance of a virtual advocacy leader to be successful in the field of healthcare analytics and advocacy.

13. I already hold a Bachelors Degree. Can I apply for this program?

Yes, you can apply. Upon graduation, you will earn a second Bachelor Degree.

14. I already hold a bachelors degree. Can you waive all the prerequisite courses?

No, despite holding a prior degree, prerequisite requirements cannot be waived. However, applicable courses from your prior degree may be used toward the prerequisite requirements.

15. When I graduate, what degree will I earn?

You will earn a Bachelor of Science in Healthcare Analytics and Advocacy. Your degree will be awarded from The University of Texas MD Anderson Cancer Center.
